REPRESENTATIVE CASES

J.M.G. v. LAUSD

Mr. Andrade successfully defended a difficult and complex matter with ten plaintiffs, obtaining a full defense verdict after a four-week jury trial with five Plaintiffs seeking \$24.5 million in damages. The Los Angeles Daily Journal recognized this result as a Top Defense Verdict. That trial result allowed for the entire litigation with all ten plaintiffs to be subsequently resolved.

Multiple v. LAUSD

Mr. Andrade successfully led the defense of numerous other high-profile tort (multi-plaintiff and single plaintiff) cases, resolving several via successful motions for summary judgment and judgment on the pleadings. One was resolved via a damages-only jury trial, and many others were resolved in successful settlements.

NEW CENTURY v. LIBERTY MUTUAL ET AL.

In a complex, multi-million-dollar coverage dispute against its former insurer and broker, Mr. Andrade prepared the entire case for trial, obtaining a pre-trial settlement with the broker, and then, second chaired the jury trial that settled against the insurer for full policy limits after week three.

LAUSD v. CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES

Mr. Andrade has handled numerous appeals in an ongoing dispute with the Department of Health Care Services over its Medi-Cal reimbursement formula and audit process with over \$10 million at issue. This representation has included numerous informal administrative hearings and a two-week formal administrative trial.
