TRIALS & ARBITRATIONS

- Obtained appellate court affirmance of order dismissing with prejudice a Federal Civil Rights claim alleging religious discrimination against a County School Board. *Chabad Chayil, Inc. v. Sch. Bd. of Miami-Dade County.*, No. 21-10619, 2022 U.S. App. LEXIS 25191, 11th Circuit, **September 8, 2022**.
- Obtained defense verdict in 4-day trial on exhaustion of PIP benefits defense in Personal Injury Protection case against medical provider Silverland Medical Center claiming breach of contract. *Silverland Medical Center aao Rafael Betancourt v. State Farm Mutual Automobile Insurance Company*, Case No. 14-01580-SP-21, 11th Circuit, **August 3. 2022**.
- Obtained complete defense verdict in 3-week trial in lawsuit by owners of the historic Deauville Hotel seeking over \$200 million dollars in damages. *Deauville Hotel Property, LLC v. Trane U.S., Inc.,* Case No. 19-16336, 11th Circuit, **July 28, 2022**.
- Obtained defense verdict for a cruise line after a 5-day arbitration. Claimant, a crew member from Costa Rica, alleged he was injured when he was lifting a heavy night stand on a cruise ship. Claimant asserted the cruise line was negligent for failing to provide proper training, failing to provide the proper amount of crew members to perform his duties, failing to provide prompt, proper and adequate medical care, and failing to provide maintenance and cure. Claimant sought over \$1.7 million dollars in damages. Bertram Livingston Burke Segura v. Royal Caribbean Cruises, Ltd., Case No. 01-19-0002-1738, April 7, 2022.
- Obtained a defense verdict after a jury determined that the retailer did not have actual or constructive notice of spill from ceiling on which the customer slipped, it owed no duty to warn her of the condition, and the incident was not foreseeable. The Plaintiff sought over \$4.2 million dollars in damages which included over \$300,000.00 in past medical expenses after undergoing lumbar spine surgery. This was the longest post-COVID trial in the Southern District of Florida and was part of the Court's Pilot Jury Trial Program. *Tomasa Fortaneli Ponce v. Walmart Stores East, LP*, Case No. 20-CV-61608-RAR, S.D.Fla., June 14, 2021.
- Obtained a defense verdict after a jury determined that the retailer did not have actual or constructive notice of the oily spill on which the customer slipped, it owed no duty to warn her of the condition, and the incident was not foreseeable. Fabiola Ortega Guzman v. Sam's East, Inc. d/b/a Sam's Club, Case No. 16-CV-81977-Rosenberg/Reinhart, in the U.S. District Court for the Southern District of Florida, West Palm Beach Division, February 2020.

SUMMARY JUDGEMENTS

- Obtained affirmed summary judgment from the First District Court of Appeal entered against Plaintiff on all of her claims against Courtyard by Marriott relating to her personal injury claims after she was run over by an ATV at Jacksonville Beach. *Dodaj v. Marriott Hotel Holdings, LP, et al.*, No. 1D 21-3721, Fla. 1st DCA, **November 23, 2022**.
- Obtained affirmed summary judgment from the Third District Court of Appeal for lawn service company sued
 for injuries suffered by Plaintiff on county land the lawn company was contracted by the county to maintain.
 Mitchell v. Ginley Lawn Serv. & Landscaping, Inc., et. al., No. 3D21-0779, Fla. 3d DCA, November 23, 2022.

SUMMARY JUDGEMENTS CONTINUED

- Obtained affirmed summary judgment from the Eleventh Circuit Court of Appeals for Sam's Club after concluding Sam's Club did not have actual or constructive notice of any alleged dangerous condition on the store's floor. Hernandez v. Sam's E., Inc., No. 21-13039, 2022 U.S. App. LEXIS 30015, 11th Circuit, October 28, 2022.
- Obtained order granting summary judgment on slip and fall matter. Torina Shetler v. Wal-Mart Stores East, LP, Case No. 6:20-cv-1985-ACC-EJK, U.S. District Court, Middle District of Florida, Orlando Division, August 30, 2022.
- Obtained dismissal of Florida personal injury claim on Application of Foreign Statute of Limitations. *Wooten v. Hilton Grand Vacations Management, LLC,* Case No. 2022-CA-000966-O, 9th Circuit in and for Orange County, Florida, August 8, 2022.
- Obtained order granting partial summary judgment in favor of a national retailer in a personal injury case dismissing Plaintiff's claims of non-medical and economic losses in excess of \$65 million dollars. *Jacques De Bruijn v. Wal-Mart Stores East, LP*, Case No.: CACE 18-008478, 17th Circuit, **July 20, 2022**.
- Obtained order granting summary judgment in a premises liability case. Judgment was in favor of a national retailer. The Court found Plaintiff failed to establish that the retailer had actual or constructive notice of the condition on which Plaintiff slipped. *Elimaniel Gonzalez v. Wal-Mart Stores East, LP, Case No.* 8:21-cv-02077-KKM-JSS, U.S. District Court, Middle District of Florida, Tampa Division, July 12, 2022.
- Obtained order granting partial summary judgment in premises liability case by a Plaintiff claiming personal
 injuries after slipping on rainwater at the entranceway of a big box retailer store based on lack of evidence
 that Walmart had actual or constructive notice of the rainwater on the floor. *Providencia De Figueras v. Wal- Mart Stores East, LP*, Case No.: 8:21-cv-00870-SCB-CPT, U.S. District Court, Middle District of Florida, Tampa
 Division, June 30, 2022.
- Obtained order granting summary judgment in a False Imprisonment and Malicious Prosecution case. The Court agreed with Defendant that it was immune from a false imprisonment claim by virtue of Florida's shopkeeper immunity statute and that it did not commence or cause the commencement of criminal proceedings against the Plaintiffs. *Michael Alhofen and Myshel Alhofen v. Wal-Mart Stores East, L.P.*, Case No. 6:20-cv-2138-PGB-GJK, U.S. District Court, Middle District of Florida, Orlando Division, June 21, 2022.
- Obtained order granting summary judgment in a premises liability case involving a freezer door that came
 off its hinges. The Court agreed with Defendant that it was an unforeseeable "freakish accident" for which
 Defendant should not be liable. Nora Vohs v. Wal-Mart,, Case No. 2019-CA-006053-0, 9th Circuit, June 3,
 2022.
- Obtained order dismissing Prisoner Federal Civil Rights case with prejudice for failure to exhaust administrative remedies. Ham v. Acosta, Case No. 20-81071, U.S. District Court, Southern District of Florida, May 17, 2022.
- Obtained order granting summary judgment in a matter involving a vessel fire and subsequent insurance claim denial due to the Claimant's violation of the personal boat policy's residence exclusion. Progressive Select Insurance Company v. Steven LaFace, Case No. 4:21-cv-10001-JLK, U.S. District Court, Southern District of Florida, May 3, 2022.




- Obtained order granting summary judgment in toxic tort case by Deepwater Horizon oil spill response
 worker claiming personal injuries from exposure based on lack of competent exert testimony on causation.
 Rodriguez v. BP America Production Company & BP Exploration & Production, Inc., Case No. 19-20042, U.S.
 District Court, Southern District of Florida, November 21, 2019.
- Obtained order granting summary judgment on the basis that the wooden pallet on the floor were an open and obvious condition for which retailer did not owe a duty to warn of and on the basis that the incident was not foreseeable. *Jacienth Jacques v. Wal-Mart Stores, East, LP.*, Case No. 0:18-CV-60072-JEM, U.S. District Court, Southern District of Florida, October 17, 2019.
- Obtained order granting summary judgment on the basis that premises owner did not have actual or
 constructive notice of the hangers on the floor prior to the alleged incident which retailer did not owe a
 duty to warn of and on the basis that the incident was not foreseeable. *Juan Fonseca v. Wal-Mart Stores, East, LP.,* Case No. 0:18-CV-62768-DPG, U.S. District Court, Southern District of Florida, September 23, 2019.
- Obtained order granting summary judgment (affirmed on appeal to the 11th Circuit) in negligence claim involving slip and fall on liquid from an allegedly leaking HVAC unit on basis that premises owner had no actual or constructive notice of the condition even though an employee inspected area 2 minutes prior to the incident and despite the use of CCTV footage of the incident used as circumstantial evidence of notice. Palavicini v. Wal-Mart Stores E., LP, No. 18-14329, 2019 U.S. App. LEXIS 27462, 2019 WL 4316693, 11th Circuit, September 12, 2019.
- Obtained order granting summary final judgment in favor of London cargo underwriters in a coverage dispute with a commercial fresh produce grower on the basis that damage to planted in-ground crops valued at approximately \$9 million were not covered goods or merchandise under its cargo policy. Certain Underwriters at Lloyds of London, Subscribing to Policy No. B0799MC029630k v. Pero Family Farm Food Co., Ltd., Case No. 18-CIV-81680-RAR/REINHART, U.S. District Court, Southern District of Florida, 2018.
- Obtained order granting summary judgment (affirmed on appeal to the 11th Circuit) where plaintiff alleged leaking roof caused dirty liquid spill on basis that premises owner had no actual or constructive notice of the condition and finding that allegations of dirty liquid alone are insufficient for notice. Berbridge v. Sam's East, Inc. d/b/a, Sam's Club, Case No. 0:16-CV-62681-BB, 11th Circuit, March 2018.
- Obtained order granting summary judgment on the basis that pallet on floor in store aisle was an open and obvious condition which retailer did not owe a duty to warn of and which the plaintiff should have observed. *Alberto Roiz v. Wal-Mart Stores East, LP.*, Case No. 1:17-CV-21491-KMM, U.S. District Court, Southern District of Florida, **February 6, 2018**.
- Obtained order granting summary judgment where liquid on floor despite employees being near the spill
 minutes prior to incident on basis that premises owner had no actual or constructive notice of the
 condition. Ayers v. Wal-Mart Stores, East, L.P., Case No. 15-24663-CIV-GAYLES, U.S. District Court, Southern
 District of Florida, February 2017.
- Obtained order granting summary judgment in favor of cruise operator on seaman's brain injury claim brought under the Jones Act. *Kendall Walker Danderson v. Royal Caribbean Cruises, Ltd.*, Case No. 10-5933-CA-13, in the Circuit Court of the Eleventh Judicial Circuit in and for Miami Dade County, Florida, **2017**.
