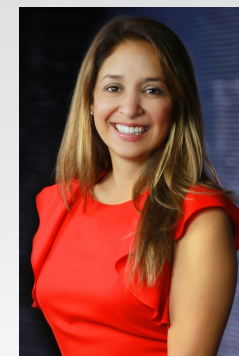
PROFESSIONAL LIABILITY
