At VISA, his work focused on legal and regulatory matters affecting the payment industry, including oversight of data privacy, consumer protection compliance, and the legal review and facilitating of financial transactions involving its members banks including their securitization of credit card receivables. Prior to VISA, Mr. Quesada had been a corporate and securities attorney at K&L Gates LLP (formerly Kirkpatrick & Lockhart LLP), advising on Securities Act and Exchange Act (1934 Act) compliance and fillings, including public offerings, private placements, and periodic reporting obligations.
