Mr. Kennedy serves as a member of the Board of PIMCO Funds, one of the country's largest open-end fund complexes. In that capacity, he serves as co-chair of the valuation oversight committee and is a member of the audit and governance committees. Mr. Kennedy also serves on the Board of the Marconi Group, a patent management company located in Dallas, Texas. Mr. Kennedy is the author of a new book, published in February 2018, titled Twelve Years of Turbulence, the Inside Story of American Airlines' Battle for Survival.

Before arriving at American, Kennedy was a litigator and bankruptcy attorney for several years in Salt Lake City. He is a 1977 Magna Cum Laude graduate of the University of Utah and a member of Phi Beta Kappa. He received his Juris Doctorate from the University of Utah School of Law in 1980.

Kennedy and his wife have four children and live in Dallas, Texas.
