Therefore, membership will only be offered to firms that devote the substantial portion of their time to, or derive the substantial portion of their revenue from, the representation of major corporate and/or public entities, and are not generally adverse to such entities.

### CRITERIA FOR ADMISSION INCLUDES

- Properly certified as a minority, women or LGBT owned, operated, managed and controlled (51% or more) firm. **Must be certified by the National Minority Supplier Development Council (NMSDC), the Women’s Business Enterprise National Council (WBENC), or The National Gay and Lesbian Chamber of Commerce (NGLCC).**
- Excellence in quality of law practiced.
- Adherence to NAMWOLF’s core values.
- Demonstrated commitment to inclusion and diversity in the legal profession.
- Favorable client references from national and regional corporations or major public entities, including corporate references within the Fortune 500.
- Martindale-Hubbell AV® Preeminent™ (4.5-5.0) Peer Review rating.
- Three or more full-time attorneys in the firm.
- Headquartered in the U.S. or Puerto Rico.
- Sufficient practice liability insurance (at least \$2 million).
- \$100 Nonrefundable Application Fee.

The NAMWOLF team performs independent research on each prospective firm. After the firm’s application is complete, the Law Firm Membership Committee reviews the collected materials and makes a recommendation for or against membership to the Board of Directors, with whom the final decision rests. **Please note no application will be reviewed three months before our Business (February) and Annual meeting (September).**
