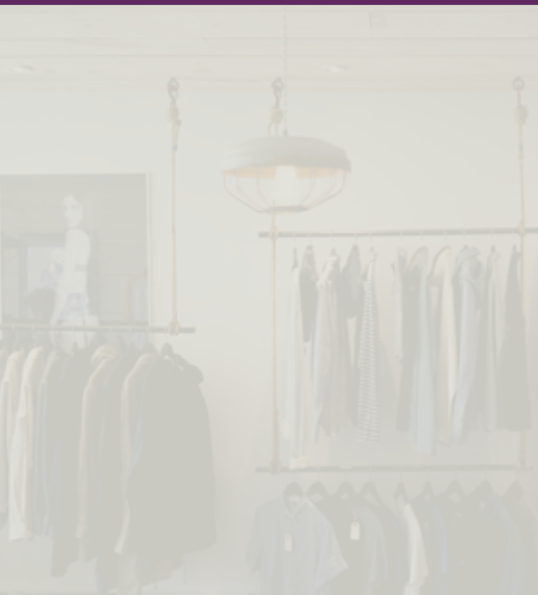

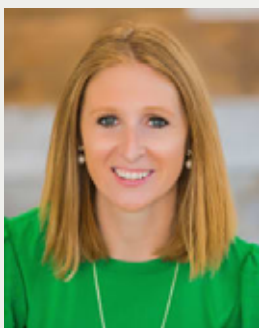
About the PAC
