Ricardo Meza

Ricardo represents clients in banking, construction and health care fields. He serves as outside general counsel to Aunt Martha's Health and Wellness, an \$85 million-dollar federally qualified health center with multiple Illinois locations. At Aunt Martha's Health and Wellness, Ricardo also serves as a key business and strategic advisor to the President and CEO where he provides advice to his client on a variety of businesses related matters.

Ricardo has extensive litigation and trial experience having served as a federal prosecutor for over 10 years. Specifically, he served as an Assistant United States Attorney in the Northern District of Illinois and the Western District of Texas and had tried over 34 federal trials, nearly all of which were to a jury. His experience and insight give him a deep context for his work, which includes handling sensitive business and litigation related issues. He has also managed and directed high-level investigations, which provide him a unique and strategic business perspective for corporations, healthcare entities, universities, non-profit organizations and public entities.

In 2010, Ricardo was senate confirmed as Illinois' executive inspector general (EIG) and served in that position until 2015. As EIG, General, Ricardo served as head of the independent Office of Executive Inspector General for the Agencies of the Illinois Governor (OEIG) where he ran all operations, including administrative and fiscal. At the OEIG, he oversaw and supervised a staff of over 75 employees, including all assistant inspectors general and investigators.

Before his tenure as EIG, Ricardo spent five years as Midwest Regional Counsel for the Mexican American Legal Defense and Educational Fund, a leading Latino civil rights organization where he led the office's litigation and public policy matters. Ricardo has also served as an assistant attorney general II in Texas where he represented the Texas Comptroller of Public Accounts in complex civil tax litigation matters, as well as in sales, use and franchise tax matters. Ricardo also served as a law clerk for the late Honorable Wendell C. Radford, US Magistrate Judge for the ED of Texas.
