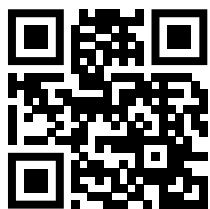

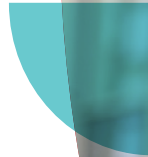

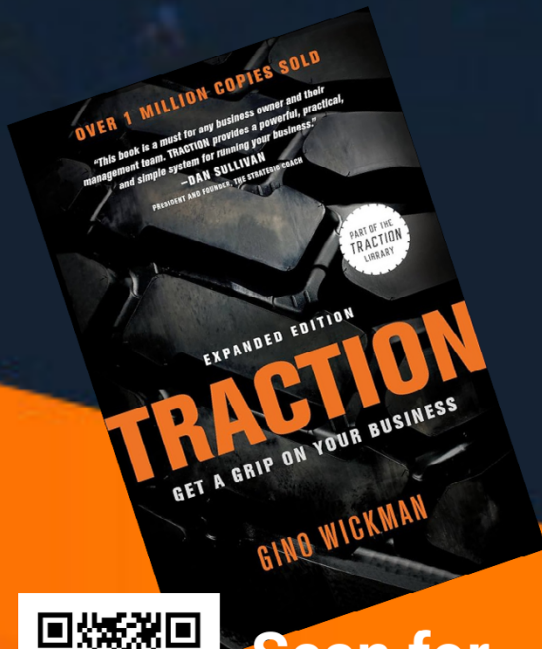
South. Committed to the pursuit of equity, she works to break barriers for young people, people of color and the marginalized through her work in the public, nonprofit and corporate sectors.
