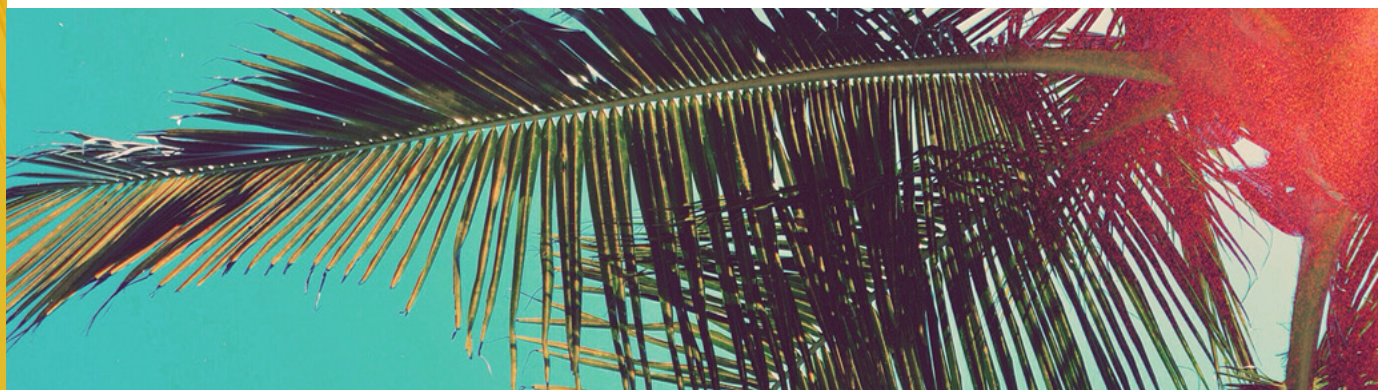

## Vernā Myers

Vernā Myers is an internationally recognized expert on diversity, equity, and inclusion. With nearly three decades of experience, she is regarded as a DEI pioneer. She is a highly sought-after DEI Keynote Speaker and DEI Consultant. She's well-known for captivating audiences with her high-energy keynotes, profound insights, and ability to foster authentic connections and meaningful dialogue. Her work as an inclusion strategist, cultural innovator, thought leader and social commentator has guided myriad organizations worldwide in dismantling barriers to inclusion and equity across race, ethnicity, gender, sexual orientation, socioeconomic class, religion, and other differences. Her expertise and

experience – personal and professional – have been instrumental in guiding workplaces toward embracing and integrating diversity, inclusion, equity, and belonging in all facets of workplace operations.

Vernā's trademarked quote, "Diversity is being invited to the party. Inclusion is being asked to dance," ® encapsulates her enduring commitment to fostering inclusive environments. The statement has been quoted countless times by professionals and everyday individuals from various industries worldwide.

Hailing from Baltimore's working class, Vernā's journey saw her rise to prominence as a distinguished alumna of Barnard College, Columbia University, and Harvard Law School, Founder & CEO of The Vernā Myers Company (TVMC), and the inaugural head of Inclusion Strategy at Netflix, where she led a global team in curating and implementing strategies to integrate cultural diversity, inclusion, and equity into all aspects of the company's operations.

An accomplished author, Vernā's two best-selling books, "Moving Diversity Forward: Going from Well-Meaning to Well-Doing" and "What If I Say The Wrong Thing? 25 Habits for Culturally Effective People" have garnered widespread acclaim. Her inspiring TED talk, "How to Overcome Our Biases? Walk Boldly Towards Them," has amassed over 5 million views and translated into 27 languages. Together with Ariana Huffington and Thrive Global, Vernā's micro-course, "Confronting Biases," has been taken by nearly a million learners worldwide and is consistently recognized as one of the top ten LinkedIn Learning courses. Vernā is also the host and producer of the podcast Sundays with Verna, which is available on Apple iTunes and Spotify.

Her company, The Vernā Myers Company (TVMC), has advised and collaborated with hundreds of legal, corporate, and academic organizations by providing cultural assessments, comprehensive strategic diversity action plans, interactive workshops, and leadership consulting. TVMC also provides its own brand of DEI online training courses on [www.tvmcu.com](http://www.tvmcu.com). The courses featuring Verna showcase her energy and her no-shame, blame, or attack approach. For eleven years, Vernā and TVMC sponsored their highly successful annual invitation-only OPUS Conference, which gathered C-Suite and other executives to discuss DEI-related matters. The conference will soon be relaunched as an international gathering of leaders, bridge-builders, and advocates.

Before establishing TVMC, Vernā was the first Executive Director of The Boston Law Firm Group. She also served as the Deputy Chief of Staff for the Attorney General of Massachusetts (1997-1999). She practiced corporate and real estate law in Boston for six years.

Vernā's impact has been recognized by numerous institutions, including the California Association of Black Lawyers and the Black Women Lawyers Association of Los Angeles Foundation. Her awards include CODE Crew DEI Person of the Year (2021), Diversity Woman Top 100 Black Women Executives, Diversity Champion award from Pepper Hamilton LLP, "Diversity Hero" by The Massachusetts Lawyer's Weekly, "25 Influential Black Women in Business" by The Network Journal, and the 2024 Trailblazer in Gender Equity & Diversity Award by Women Business Collaborative (WBC). Vernā received an honorary Juris degree from Santa Clara University School of Law (2024), was elected as a Fellow of the College of Law Practice Management, and serves as a Board Member of UC Hastings College of Law's Work Life Law program.

## **Nikki Hart** | *General Counsel* | **ATHLETES UNLIMITED**

Nikki Hart is General Counsel at Athletes Unlimited, an innovative professional sports league that breaks the model of traditional professional sports and aims to empower athletes as leaders, promote inclusive ownership and provide women unprecedented opportunities in professional sports. With a law degree summa cum laude from St. John's University, Nikki has held various senior positions in the sports and entertainment industry over a 20-year span, including Associate Counsel for the National Football League, where she focused on intellectual property, sponsorship, marketing, licensing and player development for the League and all 32 clubs; VP Business Integrations and Associate General Counsel for Speedo North America through the 2012 and 2016 Olympics, where she proudly

helped the organization and its sponsored athletes navigate the ever-changing landscape of Olympic eligibility rules; and as Vice President Business & Legal Affairs at AXS Group, LLC, AEG's wholly-owned ticketing company that services music and live sports venues worldwide. She has spoken frequently about Ambush Marketing, Olympic Eligibility Rules & their Impact on Marketing, Right of Publicity/Name-Image-Likeness Issues, and Pay Equity in Sports. She found her role at Athletes Unlimited right at a time that she needed daily work that was more impactful and meaning, and she could not be more grateful to align her desire for impact and meaning with an organization that was structured for it from its first building block. Her diverse legal background in sports and entertainment is complemented with a Master in Social Work, experience as an Adjunct Professor for Sports Law at Loyola Law School and a love for creative writing and expression. Prior to receiving her J.D., Nikki worked with adolescent foster care children in New York City, as a teacher and coach for a number of sports at an independent artistic school in New York City, and an assistant swim coach at New York University. She attended Georgetown University on a swim and academic scholarship. Nikki currently resides in Venice, California with her son and twin daughters (all teenagers!).
